**A RESOLUTION OF THE ELECTION COMMISSION OF
THE PROPOSED MUNICIPALITY OF NIWOT FIXING THE BALLOT TITLES FOR
THE QUESTIONS FOR THE ELECTION ON TUESDAY, NOVEMBER 3, 2026**

WHEREAS, on May 21, 2026, the Boulder County District Court entered an order finding and determining that the territory of the proposed Municipality of Niwot and the circulated petition met the requirements of § 31-2-101, C.R.S., and appointing six individuals to serve on the Election Commission for purposes of organizing the incorporation election; and

WHEREAS, the primary purpose of the Election Commission of the proposed Municipality of Niwot is to coordinate the election for the incorporation of the proposed Municipality of Niwot; and

WHEREAS, the Election Commission will also coordinate the election on the question of the formation of a charter commission and election of charter commission members; and

WHEREAS, the Election Commission will also coordinate the election on local government matters arising under Section 20 of Article X of the Colorado Constitution, as applied to the proposed municipality, with each question submitted to the electors of the proposed municipality exactly as set forth in the Attachment to Resolution 2026-04: Ballot Titles for Questions 1 to 8; and

WHEREAS, the Election Commission held its first meeting on June 8, 2026; and

WHEREAS, at its first meeting, the Election Commission called for an election on November 3, 2026, to be held as a coordinated election with Boulder County, as set forth in Resolution 2026-02; and

WHEREAS, pursuant to §§ 31-2-102 and 31-2-209, C.R.S., the Election Commission fixes the ballot titles for the questions to be submitted at the November 3, 2026 election.

**NOW, THEREFORE, BE IT RESOLVED BY THE ELECTION COMMISSION OF
THE PROPOSED MUNICIPALITY OF NIWOT, COLORADO:**

Section 1. The Election Commission hereby refers and approves the ballot titles for Questions 1 to 8 for submission to the qualified electors in the territory of the proposed Municipality of Niwot at the election to be held on November 3, 2026, as put forth in the Attachment to Resolution 2026-04 of the Election Commission of the Proposed Municipality of Niwot: Ballot Titles for Questions 1 to 8.

Section 2. The Election Commission sets the precinct boundaries. There is one election precinct, the boundaries of which are identical to the boundaries of the territory described in the Petition for Incorporation of the Municipality of Niwot and for the Initiation of Proceedings for the Adoption of a Home Rule Charter filed in Case No. 2026CV30306 in the Boulder County District Court.

Section 3. The Election Commission designates any ballot return box or other ballot drop-off location operated by the Boulder County Elections as the designated ballot return location for this election.

Section 4. The Election Commission authorizes the Chair of the Commission to execute the Intergovernmental Agreement with the Boulder County Clerk and Recorder for purposes of participating in the coordinated election with Boulder County.

Section 5. Effective Date. This Resolution shall take effect upon its approval by the Election Commission.
